

ORDINANCE 2021-14

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF DESHA, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE TO PROVIDE FOR THE LEVY OF AD VALOREM TAXES ON REAL AND PERSONAL PROPERTY FOR THE YEAR 2021 TO BE COLLECTED DURING THE CALENDAR YEAR 2022."

ARTICLE 1. IN ACCORDANCE WITH ARTICLE 7, SECTION 30 AND ARTICLE 16 SECTION 11 OF THE ARKANSAS CONSTITUTION AND THE PROVISION OF SECTION 85 OF ARKANSAS ACT 742 OF 1977, THE FOLLOWING AD VALOREM TAX RATES ARE HEREBY LEVIED ON REAL AND PERSONAL PROPERTY IN 2021 PAYBLE IN THE YEAR 2022.
