

ORDINANCE 2022 7

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF DESHA,  
STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED " AN ORDINANCE  
TO AMEND THE 2022 BUDGET"

SECTION 1. WE HEREBY AMEND THE FOLLOWING CATEGORIES IN:  
FUND 3009, LINE 07013053, DECREASE BY \$9000 AND INCREASE  
LINE ITEM 1000-01113053 BY 9000. IN FUND 1000, LINE 04001999  
DECREASE BY \$8000 AND INCREASE LINE ITEM 1000-01113053 BY  
\$8000. DECREASE FUND 20002000-02003053 BY \$11,000 AND  
INCREASE LINE 1000-01113053 BY \$11,000.  
THIS IS A TOTAL INCREASE OF LINE 1000-01113053 IN THE AMOUNT OF  
\$28,000. THESE FUNDS WILL BE USED TO PAY THE INSURANCE ON  
GENERAL FUND OTHERS, (BUILDINGS)

SECTION 2. IF ANY PROVISION FOR THIS ORDINANCE OR THE APPLICATION  
THEREOF TO ANY PERSON OR CIRCUMSTANCE IS HELD INVALID,  
SUCH SHALL NOT AFFECT OTHER PROVISIONS OF THE APPLICATION  
OF THE ORDINANCE WHICH CAN BE GIVEN EFFECT WITHOUT THE  
INVALID PROVISIONS OR APPLICATIONS AND TO THIS END THE  
PROVISIONS OF THIS ORDINANCE ARE DECLARED TO BE SEVERABLE.



SECTION 3. IT IS HEREBY DECLARED BY THE DESHA COUNTY QUORUM COURT:


